**Part (I) : Abstract**

The sale of the specified residential properties will be divided into 2 groups (namely Group A and Group B). Each of the persons or companies interested in purchasing any of the specified residential properties is referred to below as a “registrant”. Each registrant can only participate in any **ONE** group. Registration in both groups will not be accepted and his/her/its/their registration in Group B will lapse automatically.

Each registrant must submit the following **personally (or by a representative with proper authorization document if the Registrant has previously registered under other Information on Sales Arrangements of the Development)** to 9/F, Tower 2, The Gateway, Harbour City, Tsim Sha Tsui, Kowloon, Hong Kong (“the Sales Office”) at or before 8 p.m. on the day before the First Date of Sale (“the Deadline of Submission”):-

Group A registrant who arrives at the Sales Office at any time after the Group A Attendance Registration Period shall not be eligible to participate in the balloting.

Where it is the turn of a Group A registrant to select specified residential properties that Group A registrant fails to make such a selection (whether or not there remain a sufficient number of specified residential properties for fulfilling such criteria), such registrant will cease to be eligible for selection of any specified residential properties in the Group A Unit Selection.

Where it is the turn of a Group B registrant to select specified residential property(ies) that Group B registrant fails to make such a selection (whether or not there remain a sufficient number of specified residential property(ies) for fulfilling such criteria), such registrant will cease to be eligible for selection of any specified residential properties in the Group B Unit Selection.

- ii) (If the registrant is/are individual(s)) If only one specified residential property is selected, the purchaser of such selected specified residential property shall be that Group B registrant with or without one or more relative(s) of that Group B registrant; If two specified residential properties are selected, the purchaser of one of such selected specified residential properties shall be that Group B registrant with or without one or more relative(s) of that Group B registrant, and the purchaser of the other of such selected specified residential properties shall be: (1) that Group B registrant (or any one or more persons comprising that Group B registrant) with or without one or more relative(s) of that Group B registrant; or (2) one or more relative(s) of that Group B registrant.
